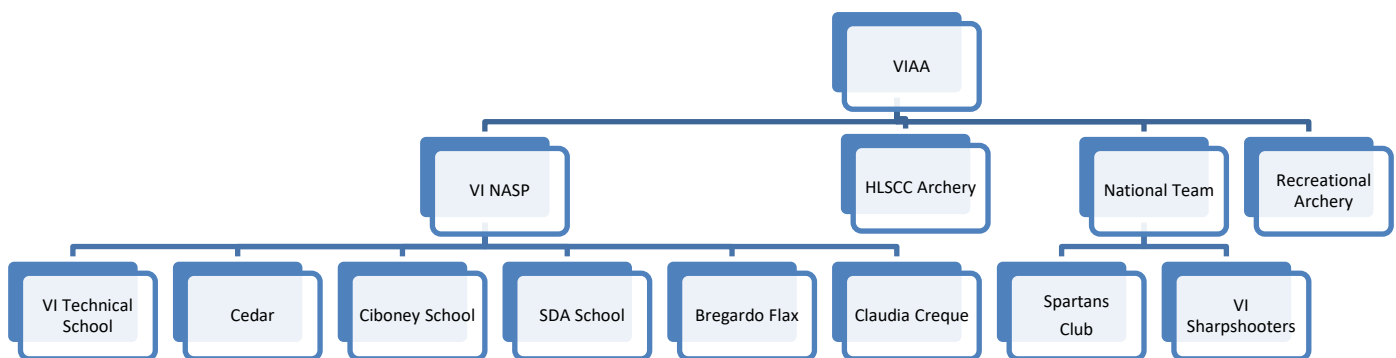
## INTRODUCTION

## EXECUTIVE SUMMARY

The VIAA is delighted to present the Annual Report for the year 2022 - 2023. Our annual year is the 1<sup>st</sup> of January until the 31<sup>st</sup> of December. In this past year, our organization has experienced some growth and achieved milestones in various areas of archery and community engagement.

## GOVERNANCE

### 1.1 Strategic Development Plan

The VI Archery Association 2016-2020 Development Plan, which was passed by our General Assembly in 2016, has been restructured for 2021-2024 and has been our focus since we restarted after COVID.

Focus Area 1 – Governance – Updating the constitution to include current changes.

- Membership policy, Addition of clubs and management policy

Focus Area 2 – Membership Services and building membership.

- Pushing for more clubs to be added. One per island, if possible, Youth clubs

Focus Area 3 – Development (Grass Root and Elite Performance)

- Increase school participation for the next year by 5 schools.
- Support clubs to build a more indebt training regime to foster athlete development.

Focus Area 4 – Partnership – Sponsors and formation of local groups and clubs.

- Partner with corporation, Rotary etc to increase awareness and recreation opportunities and participation.

Focus Area 5 – Promotional Activity

- Work with Tourist board to help promote local archery events to increase international attendees.

### 1.2 Executive Committee Meetings and Council Decisions

The Executive Committee, comprised of the President, Vice President, Secretary General, and Treasurer, convened officially three times in 2023. Additionally, there were three informal meetings, along with an Emergency General Assembly and a General Assembly.

During these meetings, the Board made pivotal decisions, including:

- Approval for the inclusion of the Assistant Treasurer/Secretary on the Executive Board.
- Approval of the appointment of the Athletes Representative to the Executive Board.

## DEVELOPMENT

### GRASSROOT PROGRAMS AND LOCAL CLUBS

#### Current Schools in the program – 6

Bregado School, VI School of Technical Studies, Seventh-Day Adventist School, Claudia Creque School, Cedar International School, Ciboney School of Excellence

Building on the progress of the preceding year, the challenge of archery not being recognized as a CXC sport has significantly diminished. Currently, our collaboration with the Ministry of Education, under the guidance of Honorable DeCastro, has proven fruitful. The program's merits were emphasized, prompting the Minister to express keen interest in extending the initiative to all schools in the territory.

Ongoing discussions with fellow Caribbean archery federations aim to establish archery as an

official sport for the CXC examinations.

Throughout the majority of the 2022-2023 school year, two schools actively participated in the program. Towards the conclusion of the fiscal year 2022, the Seventh-day Adventist school joined, and in 2023, both the Claudia Creque School and the effort to reintegrate the Bregado Flax Secondary School were successful. The program now boasts the involvement of six schools. Internationally, during the 2023-2023 season, an impressive 87,517 unique competitive archers and 34,577 Academic Archers were engaged with the program. Our local archers are proud to be contributing to these significant figures.

A local National Competition hosted at Cedar International School drew the participation of 26 individuals. At our 2023 Nationals, we proudly distributed a total of \$13,000.00 (Thirteen Thousand US dollars) in CASH scholarships to student archers. These funds were generously provided by our two annual sponsors and Unite BVI. Additionally, \$2,100.00 (Two Thousand One Hundred US Dollars) was disbursed to colleges from previous scholarship winners.

## **ATHLETE DEVELOPMENT**

### **Recurve Division**

In the Female Recurve division, we take pride in showcasing the diverse developmental stages of our four talented young ladies, all falling within the Under 15 and U17 categories.

Kasadiyah Baird and Jaydian Fahie-Smith have been integral members of the VI Archery Association since its inception, currently refining their skills at 30 meters. Notably, at the 2023 Caribbean Developmental Championships, Jaydian demonstrated her growing prowess by achieving an average score of 5.57 on qualification day. Her performance has placed her on the selection list for a coveted spot at a 2024 recurve training camp, pending parental approval, marking a remarkable stride in her progress.

While Kasadiyah couldn't attend the CDC 2023 due to school conflicts, she is actively working on a training development plan to continue her growth. Another 13-year-old archer, Ava Ghiorse, faced similar logistical challenges and school commitments, preventing her from participating in the championships. Introduced to archery through our VI National Archery School Program (VI NASP), Ava, despite challenges, remains dedicated and determined. Both Ava and Kasadiyah aspire to participate in the Flight Junior Division at the Las Vegas Shoot, and efforts are underway to raise funds for their travel.

Kellyann Tillack, our fourth U17 female recurve archer, initiated her archery journey through our grassroots program, VI NASP. As a scholarship winner standing out as the 2023 Top Girl, she is actively engaged in a structured training program, with aspirations to compete on the international stage. Kellyann, along with Ava and Kasadiyah, is continues to participate in the school archery program, showcasing their commitment to skill development.



Turning to our male recurve division, we celebrate the accomplishments of David Persaud, a dedicated member who actively participated in the CDC 2023 in Tobago. With a two-year association journey since his high school graduation, David, introduced to archery through the NASP program, is currently pursuing his education at a local college. Supported by a scholarship earned was one of the top boys in NASP, he demonstrated significant development with a Qualification percentage of 5.5 at 30 meters during the CDC 2023.

### Compound Division

Now, in our Compound Development division, we have four archers. Three promising young archers and one dedicated adult male are currently in the developmental stage. Notably, two female archers, Keyara Smith and Naomi Onwufuju, showcased their talents at the CDC 2023 at 30 meters, symbolizing the positive momentum and growth within our Compound division.

Our adult male, Xavier Buxo, in the Compound division is currently shooting at 40 meters with a training average of 8.0. As he works towards the 50-meter mark, he has planned to make his international debut at the Las Vegas Shoot 2024 in the ‘Open’ Division. His current average at 18 meters, preparation for the indoor Las Vegas Shoot is also 8.0. Following this competition, his training will be reassessed to plan for upcoming competitions he intends to participate in.

Among our promising young archers in the Compound division is Valentin Zahrebelnyj, a scholarship winner from our VI NASP program. Currently shooting at 20 meters, Valentin's training involves shooting practices with recurve to refine body mechanics and form. While he's still deciding on his path, he looks forward to the CDC 2024 in Jamaica. Valentin recently shooting in our compound division since he started in September 2024. Following his training plan, he should be comfortably shooting at 30 meters in preparation for the CDC 2024 by April 2024.

## **1.1 Coaching**

In the current year, regrettably, the coaching team could not participate in any international training seminars. Despite our earnest efforts to organize a coaching/athlete camp, the VI Archery Association faced budgetary constraints that prevented its realization. However, we remain optimistic about future opportunities for development and growth.

## **1.2 Training Camp/Training Courses**

During this cycle, VIAA successfully hosted two VI NASP Instructor certification courses, demonstrating our commitment to education in archery. Regrettably, one course had to be postponed due to lower-than-anticipated enrollment, but we remain dedicated to rescheduling.

On a positive note, one of our athletes embarked on a valuable training journey in Miami, FL. This intensive week-long program involved collaboration with three experienced coaches, gearing up for the CAC Games. The total cost for this enriching experience amounted to \$3,550.00 (Three Thousand Five Hundred fifty US Dollars), an investment in our athlete's skill enhancement and overall development.

## **Financials**

### **1.3 Budget Allocation**

Despite the Treasurer being temporarily unavailable due to family responsibilities, our Secretary General has taken on the challenge, ensuring that our financial records remain current. In early November, we enthusiastically welcomed volunteers for the Public Relations Officer and Assistant Secretary/Treasurer positions after advertising on our Facebook page and group.

Celebrating our achievements this year, the 1st Annual D'Foster Cup National Competition was able to raise funds in the amount of \$851.50 (Eight Hundred Fifty-One US Dollars and Fifty Cents), and a successful can drive organized by our fundraising committee raised an impressive \$856.32 (Eight Hundred fifty-Six US Dollars and Fifty-two Cents). We also had an additional fundraiser at the Lions Club Christmas Tree lighting before the end of last year. Additionally, our National Archery in the Schools Program received substantial support, accumulating a total of \$1,100.00 (One Thousand One Hundred US Dollars) from our Nationals and BAI courses.

Our financial outlook is a work in progress as we aim to raise funds for the Association, which is sorely lacking. The money given by our two annual sponsors is solely for our VI NASP scholarship arm. It is VIAA's aim to secure ongoing partnerships and expand our annual sponsor base to grow the VI NASP scholarship program. At the beginning of December 2022 our bank balance stood at \$35,428.49 (Thirty-five Thousand Four Hundred Twenty Eight US Dollars and Forty Nine Cents) with 90% of these funds for our scholarship program. The detailed breakdown in our forthcoming Income and Expense Report will showcase our current financial position for the year.

## Events

### 1. 2023 VI NASP National Championships – April 2023

The annual anticipated 2023 VI National Archery in the Schools Championships unfolded at Cedar School International, bringing together two competing schools vying for lucrative CASH scholarships. A total of \$13,000.00 (Thirteen Thousand US dollars) was disbursed alongside trophies, prize bows, and medals, recognizing the top 5 girls and boys as well as the overall winning team.

Our enduring partnerships with main sponsors Kobre & Kim (BVI) LP and Caribbean Security Limited have been instrumental in contributing a combined annual total of \$6,000.00 (Six Thousand US Dollars). Despite missing out on the US match this year due to delayed reporting in the previous year—attributed to our Country Coordinator's recovery from maternity leave—Unite BVI stepped in magnanimously. Their generous contribution of \$15,000.00 (Fifteen thousand US dollars) fortified the VI NASP program, enabling an additional \$7,000.00 (Seven Thousand US Dollars) in CASH scholarships. This allocation included \$7,000.00 (Seven Thousand US Dollars) designated for providing archery kits to Ciboney School and Claudia Creque, while an additional \$1,000.00 (One Thousand US Dollars) assisted in organizing the tournament.



Celebrating a noteworthy achievement, our youth programs experienced a remarkable 13% surge in participation among young archers. This success underscores our initiative's effectiveness in nurturing a passion for archery from an early age through the Archery in the Schools Program (VINASP). This not only enhances our youth programs but also contributes to a larger pool for selecting national representatives. The growth and impact of these initiatives exemplify our commitment to the development and success of archery among the youth in our community.

## 2. Central American and Caribbean Games – June – July 2023

In July 2023, the Central American and Caribbean Games took place in San Salvador, El Salvador. The delegation, consisted of a coach, an athlete, and her spouse—who serves as bow mechanic—traveled to participate in the following event. Originally, the athlete planned to provide for her nursing infant and spouse to travel, with expenses being covered by the Ministry of Education and Culture. However, two weeks prior to departure, unforeseen circumstances arose, whereby alternative arrangements as staying in the village with the infant was not permitted.

Although the government covered the expenses for the athlete's husband, there is an outstanding reimbursement of \$742.00 due from the National Olympic Committee for the athletes lodging expenses. The late confirmation of El Salvador hosting the games, impacted the event and in turn the trip's logistics. Additionally, limited vegan food options posed a challenge, making sustenance a concern.

While the athlete didn't secure a spot in the medal rounds, the experience of participating and collaborating with athletes from diverse countries in the spirit of Olympism was incredibly fulfilling. Flights for both the coach and athlete were initially covered by the athlete and later reimbursed by the Olympic Committee.

The coach's lodging expenses were supported by the Olympic Committee. Conversely, the athlete's lodging, self-financed, awaits reimbursement by the Olympic Committee, pending the return of the OC Treasurer.

## 3. Caribbean Developmental Championships- CDC September 2023

In September 2023, the vibrant Caribbean Developmental Championship unfolded in Tobago, creating an exciting platform for archery enthusiasts. Representing the BVI, a spirited team



consisting of 4 athletes, 1 coach, and 1 parent embarked on this enriching journey. Adding to the camaraderie, a national of Tobago enthusiastically joined forces with the BVI team, resulting in a formidable lineup of 5 archers.

Within the Recurve division, our talented trio comprised 2 males and 1 female, showcasing exceptional skills on the archery field. Notable achievements in this category include:

In the Compound Division, our dynamic duo of female athletes made significant strides, achieving commendable results:

**Keyara Smith** – U17: Clinching 1 Silver and 1 Bronze.

**Naomi Onwufuju** – U17: Displaying remarkable prowess in the competition.

This event not only fostered spirited competition but also provided a platform for cultural exchange and collaboration among archers from

diverse backgrounds. The positive outcomes and achievements of our team members exemplify the dedication and skill within our archery community.

In the scorching temperatures soaring into the 100s and navigating through unforeseen equipment challenges, our young athletes exhibited an extraordinary level of grit and determination, elevating their overall experience at the Caribbean Developmental Championship in Tobago. Despite the adversities, their unwavering commitment to the sport shone through, enhancing not only their personal growth but also contributing to the collective spirit of resilience within the BVI archery team.

Amidst the heat and equipment hurdles, our archers showcased a commendable blend of skill, resilience, and sportsmanship, embodying the true spirit of the sport. Their ability to rise above challenges not only added to the richness of their individual experiences but also became a source of inspiration for the entire archery community. This demonstration of perseverance in adverse conditions further solidifies the character and dedication of our young athletes, promising a bright future for archery in the BVI.

## Judging

### 1. Continental Seminar in Tobago

In the days leading up to the CDC 2023 and in coordination with the competition in Tobago, an enlightening continental judges' seminar unfolded. Our dedicated judge, Winnette

Lawrence, actively participated in this valuable event, showcasing her commitment to professional development. With unwavering dedication, Ms. Lawrence successfully completed the seminar's comprehensive course and exam, now proudly holding the esteemed status of a continental judge. This achievement not only underscores her expertise but also contributes to the overall enhancement of our archery community, fostering a culture of continuous learning and excellence.

## **2. Continuing Judge Education, Appointment,**

VIAA remains actively engaged in the search for individuals interested in pursuing a role as judges. Concurrently, our existing Continental Judge is committed to pursuing ongoing educational opportunities, aiming to advance to the next level in their professional journey.

## **INFRASTRUCTURE**

While we are in the process of securing a permanent location for our national practices, discussions have been initiated with a member of the community regarding range usage. Although finding flat land for our range remains a challenge, we are actively trying to address this situation. Currently, our primary range is situated at the H. Lavity Stoutt Community College grounds.

## **PARTNERSHIPS AND SPONSORS**

### **Sponsors**

VIAA currently has two annual sponsors for the Scholarship Program which are Kobre & Kim (BVI) LP and Caribbean Security Limited. These sponsors have supported the Schools Scholarship program since 2017. This year we have received assistance from Unite BVI, providing funds for the Archery in the Schools Program.

### **World Archery**

We are actively seeking other partnerships. We are current members of World Archery Americas and remain in good standing. To maintain this status, we are working on developing more athletes that can represent the VI on the International stage at world ranking events.

### **NASP® (National Archery in the School Program)**

We have successfully sustained our partnership with the National Archery in the Schools Program, with the Country Coordinator overseeing two training sessions this fiscal year. Moreover, we have successfully enrolled two additional schools in the program, thereby expanding our outreach.

In the realm of scholarships, we take pride in announcing that we have allocated a total of \$70,000.00 (Seventy Thousand US Dollars) for post-secondary education since the inception of the program. Subsequently, we have disbursed \$15,000.00 (Fifteen Thousand US Dollars) from these funds to the recipients Post Secondary In

  - a. VIAA is planning to bid to host the 2025 CDC and will be working with the local government, DYAS and local sponsors to cover the event. This will be the first major archery competition hosted in the Virgin Islands and will bring individuals from the US, Canada and the Caribbean.
4. Preparing our athletes for Pan Am Juniors and Seniors Championships
5. Preparing our athletes for the Caribbean Developmental Championships for July 2024 in Jamaica
6. VINASP Country Coordinator to attend the Coordinator Conference in Fort Worth, Texas in July
7. Organizing a Corporate League - Event for one of our Clubs to assist with raising funds.
8. Organizing the Rotary “Battle of the Clubs” – Event for one of our Clubs to assist with raising funds.
9. Turkey Hunt 2024
10. Organizing a hunting season with the Ministry of Natural Resources and Labour – Hunting of goats on the Bird Sanctuary
11. Organizing additional local competitions to give athletes more competition experience.
